SECRETARY - TREASURER'S REPORT - 1983

YOUR OFFICERS AND EXECUTIVE COMMITTEE HELD THEIR ANNUAL FALL MEETING AT THIS HOTEL ON NOVEMBER 10, 1982. MOST OF THAT MEETING INVOLVED PLANNING FOR THIS CODE SEMINAR.

AS MOST OF YOU KNOW, THE IAEI HAS NOW PURCHASED AND IS OCCUPYING ITS OWN OFFICE BUILDING IN PARK RIDGE, ILLINOIS. A BUILDING FUND WAS INITIATED WITH A GOAL OF \$150,000.00. YOUR EXECUTIVE COMMITTEE VOTED TO CONTRIBUTE \$1,000.00 TO THIS BUILDING FUND IN THE NAME OF THE WISCONSIN CHAPTER. \$500.00 WAS CONTRIBUTED THIS YEAR AND \$500.00 WILL BE CONTRIBUTED IN 1984.

OUR CHAPTER HAS ADDED 32 NEW MEMBERS SINCE LAST MAY. OUR CURRENT MEMBERSHIP INCLUDES 148 ACTIVE MEMBERS, 168 ASSOCIATE MEMBERS, 3 STUDENT MEMBERS, 9 RETIRED MEMBERS AND 4 COOP MEMBERS FOR A TOTAL OF 332. OUR NEW MEMBERS ARE AS FOLLOWS: READ NAMES

THE CHAPTER FINANCIAL BOOKS WERE AUDITED AND APPROVED BY Gary Hacker AND Ray Weber ON MAY 3, 1983. OUR TREASURY BALANCE ON HAND DECEMBER 31, 1982 WAS \$4,443.14 SO WE ARE IN A GOOD FINANCIAL CONDITION. WE SHOULD KEEP IN MIND HOWEVER, THAT THE 1986 WESTERN SECTION CONFERENCE WILL BE HELD IN MILWAUKEE SO WE MAY WANT TO START DOING SOME PROMOTIONAL ACTIVITY IN 1984 and 1985.

ALTHOUGH OSHKOSH LOST OUT TO APPLETON AS THE SITE OF THIS SEMINAR IN A HOTLY CONTESTED CONTEST LAST YEAR, I UNDERSTAND THAT THEY STILL ARE ANXIOUS TO HOST OUR 1984 SEMINAR. WE WILL MAKE A SELECTION AT FRIDAY MORNINGS BUSINESS SESSION.

THE 1984 NEC WILL BE PUBLISHED AND AVAILABLE LATER THIS SUMMER. EACH IAEI MEMBER IN GOOD STANDING WILL BE SENT A FREE COPY. PART OF THIS IS MADE POSSIBLE BY THE GENEROSITY OF THE NFPA IN PROVIDING FREE COPIES TO ALL ACTIVE INSPECTORS. THE IAEI PAYS THE SHIPPING COSTS FOR ALL COPIES AND IN ADDITION PAYS FOR THE COST OF COPIES FOR OUR ASSOCIATE MEMBERS. WE APPRECIATE THE NFPA'S SUPPORT OF OUR ORGANIZATION.

I WOULD ALSO URGE YOU TO KEEP WATCHING THE IAEI NEW BULLETIN FOR ORDERING INFORMATION FOR ADDITIONAL COPIES OF THE 1984 NEC. THE IAEI EXPECTS TO OFFER A BULK RATE DISCOUNT.
